

## **Data Protection**

1. Person responsible for the processing: The Sponsor, whose identifying data appears in the first section of these Legal Bases, is responsible for the processing of the personal data that are provided for participation in the draw. This clause provides information on the use that TURESPAÑA will give your personal data. The purpose of this clause is to provide information about the rights of the participant under the General Data Protection Regulations (“GDPR”).
2. Purposes of the processing, legal basis and communication of data:  
By checking the box “I have read and accept the legal bases of the contest, you confirm that you are aware of the following:
  - Purpose of the processing: Management of personal data for participation in the contest
  - Legal base: Contractual relationship
  - Recipients: Your personal data will not be transferred.
  - International transfers: Your personal data will not be transferred internationally.
  - Storage term: The data will be stored during the time in which your participation in the draw is being managed.

All fields that appear in the form(s) are mandatory fields. In this respect, if any of them are omitted, this could affect your participation in the of the contest. By checking the box “I accept for TURESPAÑA to send me tourist information”, you confirm that you are aware of the following:

- Purpose of the processing: Sending of tourist information by TURESPAÑA.
- Legal base: Consent.
- Recipients: Your personal data will not be transferred.
- International transfers: Your personal data will not be transferred internationally.
- Storage term: Your personal data will be hold until you communicate TURESPAÑA that you would like to unsuscribe the registration.

By clicking on the “I accept” button (or equivalent) incorporated into the form(s), you declare that the information and data you have provided in them are accurate and true.

3. Rights of the interested parties: We inform you that you can exercise the following rights:
- I. right of access to your personal data to know which data are being handled, as well as the processing operations carried out with them;
  - II. right to rectify any inaccurate personal data;
  - III. right to delete your personal data, whenever possible;
  - IV. right to request the limitation of the processing of your personal data when the accuracy, legality or necessity of the processing of the data is doubtful, in which case, we may keep the data for the exercising or defending of claims.
  - V. right to the portability of your data.
  - VI. right to revoke the consent granted to TURESPAÑA.

You can exercise the rights listed above at any time and free of charge, by sending an email to [cdatos@minetad.es](mailto:cdatos@minetad.es), attaching a copy of your ID or equivalent document, and stating what right you wish to exercise, and an address for notification purposes.

On the other hand, we inform you that you have the right to file a claim with the Spanish Data Protection Agency if you consider that there has been a breach of the legislation on data protection regarding the processing of your personal data.
